# WOOD FLOOR CLEANER

## PRODUCT DESCRIPTION:

Use Bostik's Wood Floor Cleaner everyday to safely clean all types of unwaxed flooring surfaces; finished polyurethane hardwood, laminates, ceramic and stone. It is specifically designed to be used with no need to dilute the packaged product.

## DIRECTIONS FOR USE:

**For Unwaxed Floors:** Sweep or vacuum floor to remove loose dirt.

**TOWELS:** Open lid, pull out towels and wipe floor.

**QUART SPRAY BOTTLE:** Spray Bostik's Wood Floor Cleaner directly onto floor and wipe with mop, sponge or appropriate cleaning applicator.

**GALLON CONTAINER:** Apply Bostik's Wood Floor Cleaner on floor and wipe with mop, sponge or appropriate cleaning applicator.

For tough to remove stains or heel marks apply directly to area and rub clean with cloth. Do not allow puddles of cleaner to remain on floor. Do not use on oil, waxed or unfinished wood floors.

## LIMITATIONS:

- Not recommended for oil, wax or unfinished wood floors.
- Over saturating or forming puddles for an extended period of time may cause staining.
- Always do a test in an inconspicuous area to ensure product satisfaction.
